## **President's Column**

## Philes' Forum

Hello Bimmerphiles! This time out I have another coolingsystem maintenance tip for you E30 M3 pilots.

I still wish to receive copies of your DMV emissions-inspection reports. You can either mail a photocopy of your report [preferred], or simply e-mail the test data. [Include your name, too, if you want to be famous and be mentioned in Philes' Forum!] If you e-mail, please include both the test results and the pass/fail criterion for each pollutant along with your model and year, transmission type, and mileage. If you know at what mileages your oxygen sensor and spark plugs were last replaced, include them as well. Please indicate what, if any, modifications have been made to your motor [aftermarket chip, intake, exhaust, etc.] and your exact model number [eg: 328i, not 3-Series].

Recent submitters of emissions-test data are Bimmerphiles Mark Derienzo [Member-At-Large and Tech worker], Ed Levey, Bill Molina, Doug Raichle, our beloved Dr. of Autocrossing Elihu Savad, and M5 pilot/Tech worker George Washburn. Thanks, guys!

As you read this, the 2006 NJ Chapter Driver School Season will have already begun. At the schools we see that E30 ['88-'91] M3s seem to have relatively short water-pump life. We also see that new pumps sourced from a BMW dealer seem to outlast pumps from aftermarket suppliers. I'm not sure exactly why this is, but the consensus in the

E30 M3 Driver-School set is that only the OEM water pump should be used. A couple seasons ago, Al Drugos went through three new aftermarket water pumps, each lasting only a few hours! And yes, my own M3 got an OEM water pump when it was changed a couple years ago.

I believe one reason for short water-pump life on the E30 M3 is the high-RPM nature of the S14 motor. The motor has to be wound up pretty tightly to produce any power. Another factor is the 4.10 final-drive ratio, which, with equal tire

sizes, will have an E30 M3 motor spinning about 10% faster on the highway than a 6-cylinder E30 325is. The higher RPM magnifies any imbalance in the mechanical cooling fan, and this increases the load on the pump bearings. Once the bearings begin to fail, the pump seal is usually history.

For track-driven E30 M3s, I believe you can help lengthen water-pump life by removing the mechanical fan and its plastic shroud while you are at the track. This is readily accomplished with a 32 mm, thin-headed, open-end wrench. Remember the fan threads are left-handed! At speed, the mechanical fan does nothing to cool the motor. Indeed, I believe the shroud actually impedes ram airflow through the radiator, so removing the shroud can actually improve cooling on the track.

Your auxiliary electric cooling fan should get you back to your paddock spot after your track sessions with no overheating problems. [Some racecars have no fan at all.] The two-speed fan should come on automatically at low speed when the coolant leaving the radiator gets to about 90 C [194 F]. Uh, if you are going to remove the mechanical fan, I would ensure that the electric fan is working properly, as the E30 M3 is known for problems with the fan thermoswitch wiring.

When you change your E30 M3 water pump, pay particular attention to the heater-return connection on the left [driver side] rear of the pump. See Photo #1, taken with the alternator removed. I'll bet on your car the short piece of hose is the one the car came with! It was on my M3. With the water pump removed and the alternator moved out of the way, it is a piece of cake to change this little hose [BMW Part # 11 53 1 266 472, which lists for about \$4.].

Photo #2 depicts the hose I removed from my M3 together with the new one. 'Nuff said.

You'll note from Photo #1 that the hose clamps have hex drives in addition to screwdriver slots. This is typical for BMW coolant-hose clamps. It is much easier to remove and install these clamps with a 6 mm socket mounted on a ¼ " drive handle. See Photo #3.

Another tip for water-pump longevity is to keep your cooling system clean. I think that regular flushing and quality coolant mixed 50/50 with distilled or deionized water can extend water-pump life by reducing the wear on the pump seal.

## Online Event Registration is Live!

We are pleased to announce that we now offer an online registration system for driver school registration. We encourage you to use online registration for driver school registration to ensure accurate data transfer and to simplify our school management. We expect to see the majority of applicants register online, and plan to offer only this alternative in the future. For this reason, let's get started!

### Step 1 - Set-up / Update your account

First, if you haven't already, set-up an online account. Go to the website (www.njbmwcca.org) to create your personal "My NJBMWCCA" account - it's free, quick and easy.

Then log-in to your profile and be sure that your address, contact phone numbers and, MOST IMPORTANTLY, that your e-mail address is correct.

Next, enter your vehicle information into your account. You can enter multiple cars, and be sure to enter the one(s) that you will be using in our drivers schools.

That's it - Done! Now you are ready to register for an event.

### Step 2 - Register for a drivers school!

Click on a drivers school event in the "Upcoming Events" or "Schedule" section. To register, click the "Register Now" link. This will bring you to the registration page where you will choose the car you will bring and event dates. Verify that all information is correct and check the box, then select "Register." You will then be sent a confirming email that details the registration information. Follow the instructions on this email, and you're registered!

At 7:40 pm the meeting was called to order by President Neil Gambony at the Alphonso's Restaurant in Somerville. The reading of the February minutes was waived.

### Officers' Reports:

**President Neil Gambony** sent in the chapter application for the ZF award. Larry Engel and Neil will become Deutscher Club members; it was suggested that Paul Papparella might be another possibility. Neil is following up on tickets for this year's Auto Show.

Vice President Brian Morgan March 15th will be a meeting at the Deutscher Club on the chapter's Autocross program. The April 19th meeting will be at the Morristown BMW Mini facility. May 17th at Deutscher Club will feature BMW model cars. Brian will contact BMW NA regarding a June meeting. There are a number of BMW dealers that would like to host meetings. Ross will offer the opportunity to host meetings in July, August, September and October to long-time sponsors. Some of these meetings may be programs with speakers, rather than tech sessions.

**NJ Bulletin Editor** Jerry Faber stated that the newsletter will go to the printer tomorrow, so will not be delivered prior to the March membership meeting. We have a new sponsor, Bavarian Autosports.

**Treasurer Warren Brown** distributed the current profit/loss statement. Deposits on multiple driving schools and insurance costs traditionally result in negative numbers at this time of the year. David Hirschhorn will handle registration and David Ngo will once again be chief instructor. All event insurance waivers need to be held for 7 years. Bob will be the holder of all waivers and everyone should send any insurance waivers to him.

**Blake Smith, Chief Instructor** The Instructor Seminar was a great success. Instructor registration should be up in a week. Registration is slow, but will be promoted in the NJ Bulletin and by links on other websites. David Hirschhorn is interested in helping to promote driving schools. Online registration is progressing, but additional work is needed. We should do an email to past attendees to promote the driving schools.



### The Fine Print – Please Read Carefully

- Cancellation Policy There is a \$25 cancellation fee up until seven days (one week) before the event. After that there are no refunds for cancellation. If an event is cancelled due to inclement weather, fees will be refunded minus a \$25 charge to
- Participants must be at least 18 years old with a valid driver's license.
- Long sleeve shirts and long pants required. Cotton or other natural fiber fabric is recommended.
- Snell 95 (or later) approved helmet is required. Neck collar or other neck protection recommended.
- After-market window finting is not allowed unless inspected and approved by us, at least one week prior to the event.
- No convertible/open top cars, SUVs/SAVs or purpose-built (tubeframe,etc) racecars. A Spec Miata or similarly equipped vehicle is acceptable provided it has an SCCA approved full roll cage and bolted-on hard top.
- Equal driver/passenger seats and seafbelts, and passenger-side mirrors are required in ALL student cars.
- All cars must be muffled. Sound limit: 81 dB(a) at Lime Rock Park, 103 dB(a) at Summit Point.
- It is not possible for two students of the same level (run group) to share a car
- For advanced schools, driving experience will be verified?

### Champ Series Rules

- Autocross points are awarded by finish within class according to a set autocross point structure, regardless of the number of entries in a particular class.
- Points for all other types of competition events are awarded by a set point structure according
  upon the total number of official events in the event.
- One event from the entire calendar of events must be dropped from the point total for each participant. For example, if a particular year's schedule of events includes 10 events, a maximum of 9 events would be counted in the final tabulation.
- Points are awarded per event regardless of an entrant's BMW CCA membership, but an individual must be a NJ Chapter BMW CCA member to place in the final point standings. Nonmembers may join at any point during the season.
- When a tiebreaker must be applied, the rule of application shall be a comparison of the number of top finishes. For example, the participant with the highest total number of first place finishes shall win the tie. If the number of first place finishes is equal, then the highest total number of second place finishes shall win the tie, and so on until the tie is broken.
- Both driver and navigator score equal points in rally events.
- A rallymaster and co-rallymaster score points equal to a third place finish in a rally event for organizing and planning the rally event.
- A rally team need not complete a rally route to gain minimum points for entering the rally.
- Motorcycles may participate in rally events, but neither for official finish placement, nor for Championship Series points.
- If a car with more than two adults enters a rally, those adults shall receive equal points for their
  rally placement if and only if the rally has a special class for such entries. If the rally does not
  have such a class then the adults in the car will not receive any Championship Series points for
  their finish.
- Points for autocrosses are awarded using the Autocross point schedule according to finish for each class, regardless of the number of entries in the autocross or any particular class.
